

## PRIVACY NOTICE

This Privacy Notice (“Notice”) describes how BLOSSOM URBANE LTD, registration number: 15528430, having its registered address at Brosnan House 175 Darkes Lane, Suite 2b, Potters Bar, United Kingdom, EN6 1BW (“Company,” “we,” or “us”), collects, uses, discloses, and protects your personal data in accordance with the UK General Data Protection Regulation (UK GDPR), General Data Protection Regulation (GDPR) and other applicable data protection laws in the United Kingdom.

By accessing or using our services, you confirm that you have read and understood this Privacy Notice.

We may update this Notice from time to time to reflect changes in our data processing practices or legal requirements. Substantial changes will be communicated clearly, such as via our website or by direct notification. By continuing to use our services after changes are published, you consent to the updated Notice.

### 1. Data Controller

The Company is the “data controller,” meaning we determine the purposes and means of processing your personal data and ensure that all processing activities comply with applicable data protection laws and related regulations.

### 3. Our Principles of Data Processing

We are committed to the following principles when processing your personal data:

- a. **Lawfulness, Fairness, and Transparency:** We process your personal data in accordance with applicable laws and regulations. We act transparently and aim to communicate clearly about how your data is used and, where required, by identifying the relevant legal basis for processing;
- b. **Purpose Limitation:** We collect your personal data for specified, explicit, and legitimate purposes. We do not use your information in a way that is incompatible with those purposes, and we will update you if we plan to use your data for a new purpose where required by law;
- c. **Data Minimization:** We only collect and process personal data that is necessary for the stated purposes. We limit access to your data to those who need it for their work and avoid collecting more data than we reasonably need;
- d. **Accuracy:** We take reasonable steps to ensure that the personal data we hold is accurate and, where necessary, kept up to date;
- e. **Storage Limitation:** We keep your personal data only for as long as necessary for the purposes for which it was collected. We have defined retention periods for different types of data, and we regularly review and securely delete or

anonymize data that is no longer needed, unless we are required or permitted to keep it for legal, regulatory, tax, accounting, or dispute-resolution purposes;

- f. **Integrity and Confidentiality (Security):** We implement appropriate technical and organizational measures to protect the security, integrity, and confidentiality of your personal data, taking into account the nature of the data and the risks of processing;
- g. **Accountability:** We are responsible for complying with these principles. We regularly review our processing activities to meet our compliance obligations. Where appropriate, this includes maintaining records of processing activities, completing data protection impact assessments, using appropriate contracts with service providers acting as processors, and managing personal data breaches in line with legal requirements.

#### 4. Your Rights

You have the following rights regarding your personal data:

- **Access:** You can request access to your data and obtain a copy of it.
- **Rectification:** If your data is inaccurate or incomplete, you have the right to correct it.
- **Erasure:** Under certain conditions, you may request the deletion of your data.
- **Restriction:** You can request that we limit the processing of your data in specific situations.
- **Objection:** You have the right to object to certain types of processing, such as direct marketing.
- **Portability:** You can receive your data in a commonly used and machine-readable format and transfer it to another controller.
- **Withdrawal of Consent:** If you have given consent for the processing of your data, you can withdraw it at any time.
- **Automated Decision-Making and Profiling.** We do not make decisions producing legal or similarly significant effects based solely on automated processing (including profiling). If this changes, we will notify you and provide a way to exercise your rights, including the right to obtain human intervention, to express your view, and to contest a decision.

Please note that these rights are not absolute and may be subject to legal preconditions. Additionally, to protect your privacy and security, we may need to verify your identity before processing your request.

#### 5. How to Exercise Your Rights:

- (b) We may request information necessary to verify your identity and to locate the data (for security and fraud prevention);
- (c) We will explain any exemptions or limitations that apply (e.g., where honoring a request would adversely affect the rights and freedoms of others, conflict with legal obligations, or undermine fraud prevention or security);

- (d) We will respond within the period required by law and inform you if additional time is needed due to request complexity or volume;
- (e) Requests are typically free of charge. We may charge a reasonable fee or refuse manifestly unfounded or excessive requests as permitted by law.
- (f) Depending on your location, you may have additional rights under local law. You also have the right to lodge a complaint with your data protection authority.

## 6. Types of Personal Data We Process

We may collect, use, store, and transfer the following categories of personal data:

- **Account Data:** Information associated with your account, such as full name, place of residence, date of birth, passwords, account preferences, activity logs, referral links.
- **Contact Information:** Your name, email address, telephone number, and home or business address.
- **Technical Data:** Information about your device and technology used to access our Platform, including IP address, device type, browser type and version, operating system, and unique device identifiers.
- **Transaction Data:** Records of orders, purchases, transaction amounts, and payment history.
- **Payment Data:** Bank account numbers, payment card details, billing addresses, and related payment records.
- **Marketing Data:** Your marketing and communication preferences, participation in campaigns, and involvement in loyalty or promotional programs.
- **User Content:** Any data, documents, communications, files, or materials submitted, uploaded, or created by you through your Account or our Services.
- **Compliance Data:** Information we are required to collect for legal or regulatory compliance, including but not limited to anti-money laundering (AML), counter-terrorist financing (CFT), and Know Your Customer (KYC) obligations.
- **User Support Data:** Details generated through customer service or support interactions, including support queries, communications, and status or outcomes of your requests.

## 8. Sources of Personal Data

We collect personal data from the following sources:

- **Direct Interactions:** When you provide information by creating an account, completing forms, making a purchase, or contacting customer support.
- **Automated Means:** When you interact with our website and services, we may collect personal data automatically through cookies, analytics tools, and similar tracking technologies in accordance with our Cookie Notice.
- **Third Parties:** We may obtain personal data from payment processors, service providers, public authorities, or public records, as permitted or required by law.

## 9. Sharing and Disclosure of Personal Data

We may share your personal data with:

- **Service Providers and Partners:** Including payment processors, AI service providers, IT service providers, and analytics providers, strictly for the purposes described above and under confidentiality agreements.
- **Government Authorities and Law Enforcement:** Where required by law or to protect the rights, property, or safety of the Company, our customers, or others.

## 10. Data Retention

We retain personal data only as long as necessary to fulfill the purposes for which it was collected and to comply with legal, regulatory, tax, and accounting requirements.

We may retain personal data for:

- A minimum of 6 years for customer/account information for tax and regulatory purposes.
- Up to 5 years for AML-related compliance obligations.
- Until the expiry of relevant statutory limitation periods for potential legal claims (usually up to 10 years).

When personal data is no longer required, we securely delete or anonymize it. Data processed based on consent will be retained until consent is withdrawn.

## 11. International Data Transfers and Associated Risks

Your personal data may be transferred and processed outside the UK and/or European Economic Area (EEA) to our services providers that carry out certain functions on our behalf.

Whenever we transfer your personal data out of the UK to service providers, we ensure a similar degree of protection is afforded to it by ensuring that the following safeguards are in place:

- We will only transfer your personal data to countries that have been deemed by the UK to provide an adequate level of protection for personal data; or
- We may use specific standard contractual terms approved for use in the UK which give the transferred personal data the same protection as it has in the

UK, namely the International Data Transfer Agreement or The International Data Transfer Addendum to the European Commission's standard contractual clauses for international data transfers.

By interacting with us and using our services, you acknowledge that your data may be transferred, processed, and stored outside of the EEA as described above.

## **12. Essential and Optional Data**

Some personal data is mandatory to enable us to provide our services. Where data is required, it will be clearly indicated. You may choose whether to provide optional data, which may be managed via your account settings.

## **13. Children's Data**

Our services are not designed for individuals under the age of 18 (the "Minors"), and we do not knowingly collect or process their personal data. If you believe that a Minor's information has been shared with us, please contact us immediately so we can take steps to remove it. By using our services, you confirm that you are not a Minor.
